

Terms and Conditions of Entry for the Toyota Good for League Raffle (QLD)

First up

1. These terms and the terms in Schedule 1 and information on how to enter form the Conditions of Entry for this Raffle, and set out all the information you need to know regarding this Raffle. If there's any inconsistency between these terms and Schedule 1, then what's in Schedule 1 is correct. By submitting your entry, you agree that these Conditions of Entry apply to your entry.
2. Any capitalised terms used in these Conditions of Entry have the meaning given in Schedule 1, unless stated otherwise.
3. The promoter is Cowboys Charity Limited (ABN 89 603 728 427) a charity registered with the Australian Charities and Not-for-profits Commission and trading as the Cowboys Community Foundation, **1300SMILES Stadium, Golf Links Drive, Kirwan 4817, QLD Australia** ('**Promoter**').
4. Good2Give (**G2G**) is responsible for initially distributing the ordered tickets to clubs and the reconciliation of tickets and redistribution of all funds raised in the Raffle. Contact: 02 9929 9633 or raffle@good2give.ngo.
5. Toyota Motor Corporation Australia Limited (**Toyota**) and the North Queensland Toyota Cowboys (**Cowboys**) are promotional partners to the Promoter and G2G for the purposes of the Raffle.
6. All proceeds from the Raffle will be deposited by clubs into the 'Good2Give for the Benefit of Cowboys Community Foundation' bank account. Following the draw, a grant to the amount of funds raised will then be made to each participating Rugby League Club into the Club bank account as provided on the registration website by the Club Representative. The Promoter, Toyota and the Cowboys receive no direct financial benefit from the Raffle.
7. Any updates to these Conditions of Entry will be subject to regulatory approval, and will be published on Toyota's Website, so it's important to check these Conditions of Entry regularly.

Who can enter ... and who can't

8. The eligibility requirements for this Raffle are set out in the Entry Restrictions in Item 5.
9. Directors, management, employees, contactors (or members of their immediate family) of the Promoter or the Promoter's related entities or any of the Promoter's agents directly involved in the Raffle (as determined by the Promoter) are not eligible to enter.
10. Directors, management, employees, contactors (or members of their immediate family) of Toyota or Toyota's related entities or any of the Toyota's agents directly involved in the Raffle (as determined by the Promoter) are not eligible to enter.
11. Directors, management, employees, contactors (or members of their immediate family) of the Cowboys or Cowboys' related entities or any of the Cowboys' agents directly involved in the Raffle (as determined by the Promoter) are not eligible to enter.
12. For the purposes of these Conditions of Entry, "Immediate family" means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin, whether or not they live in the same house.

How to enter

13. The Promotion will be conducted during the Promotion Period.
14. To enter, entrants must follow the applicable Entry Procedure as described in Item 7 for Club Representatives or Participants. Club Representatives may enter the Raffle, provided they meet the eligibility criteria for the Raffle. The Promoter and/or its representatives may conduct security and/or verification checks (including enforcement of the Verification Requirements) in their absolute discretion to determine the bona fides of an entrant's eligibility to enter the Promotion. Ineligible entries will be deemed to be invalid.
15. By registering themselves and their club, each Club Representative warrants that they have the permission and authority of their club to involve their club in the Raffle. Club Representatives are personally responsible for arranging the distribution of the raffle ticket books, and sale of the raffle tickets, during the Raffle Period (Item 3). Club Representatives

are also responsible for the collection of proceeds from the sale of the raffle tickets, and reconciliation of those proceeds.

16. Each Club Representative must ensure that tickets are only sold during the Raffle Period described in Item 3 and that all ticket stubs of all tickets sold by their club, all remaining unsold tickets and all fully reconciled funds raised are returned within one week of the end of the Raffle Period (namely, by no later than 25 July 2018). Entries must be received by the Promoter and will be deemed to have been received at the time of receipt by the Promoter.
17. Club Representatives must also ensure that each ticket sold through their club has full contact details (including name, phone and address details) for the Participant that bought the ticket (or their nominee) completed on the ticket stub. In the case that a Participant purchases an entire book of Toyota Good for League Raffle tickets, all ticket stubs must be completed in full.
18. It is the Participant's responsibility to notify the Promoter if their contact details change during the Raffle Period.
19. The Promoter will not accept entries which are incomplete, illegible, or which are generated by computers or other automated means.
20. The Promoter reserves the right to disqualify an entry in the event of non-compliance with these Conditions of Entry or if, in the reasonable opinion of the Promoter, an entrant tampers or interferes with an entry mechanism in any way. If an entry is deemed invalid (at the Promoter's absolute discretion) prior to the Prize Claim Date, the Promoter may determine a new winner in accordance with the Unclaimed Prize Arrangements.
21. If the Raffle cannot run for reasons beyond the Promoter's control (for example, infection by computer virus, mobile network failure, bugs, tampering, unauthorised intervention, fraud, or technical failures), the Promoter reserves the right to cancel, suspend, modify or terminate the Raffle (subject to regulatory approval). If that happens, the Promoter will select a winner from eligible entries received at the time.
22. The Promoter may, in its sole discretion, declare any or all entries made by an entrant invalid, and/or prohibit further participation by an entrant in this Promotion or a prize event/activity if the entrant:
 - (a) disrupts, annoys, abuses, threatens, harasses or attempts to do any of these things to the Promoter, another entrant or potential entrant, or anyone else associated with, this Promotion; or
 - (b) engages in conduct in relation to this Promotion which is misleading, deceptive, fraudulent or damaging to the Promoter's good will or reputation, or the goodwill or reputation of anyone else associated with this Promotion.
23. All decisions made by the Promoter regarding any aspect of the Raffle are final, and no correspondence or negotiations will be entered into.

Prizes

24. Information about the Prize(s) and Prize Restrictions/Exclusions (if any) are set out in Schedule 1. Prize values are accurate as at the commencement date for the Raffle. Any variation after that date is beyond the Promoter's control. All costs, fees, charges or expenses associated with the Prize(s), which are not specified in Schedule 1, are the responsibility of the winner(s).
25. Prizes are not transferable, exchangeable or redeemable for cash. If for any reason a prize is not available, the Promoter and/or Toyota will substitute it for another prize of equal or higher value (in the Promoter and Toyota's sole discretion), subject to regulatory approval. The Promoter and its representatives will not be liable for any damage to or delay in transit of prizes.

How winners are chosen and notified

26. All tickets that have been paid for in full will be entered into the Draw. In the instance of incomplete or illegible identification on the entry (ticket stub) of a Participant who purchases a ticket, every endeavour will be made to identify and contact the Participant. This will include

publishing the ticket number with a request for contact, and contacting and collaborating with the Club Representative in order to identify the Participant. Tickets not paid for in full will not be included in the Draw. Any entry (ticket stub) which the Promoter deems to be slanderous, defamatory or otherwise offensive may not be included in the Draw, subject to approval from the relevant regulatory body.

27. Draw Details are set out in Item 10 of Schedule 1. The Promoter will notify winners, and publish their names, in accordance with the Notification and Publication of Winners information set out in Item 14 of Schedule 1. If a winning entry is invalid, that entry will be disregarded and the prize will be awarded by drawing the next valid entry in accordance with these Conditions of Entry.

How to claim prizes

28. All claimed prizes will be distributed to the respective winners within 30 days of the prize being validly claimed. The Promoter reserves the right to request winners to provide proof of identity, proof of age and proof of residency at the nominated prize delivery address and/or proof of entry validity in order to claim a prize. Proof of identification, age, residency and entry considered suitable for verification is at the discretion of the Promoter. In the event that a winner cannot provide suitable proof, the winner will forfeit the prize in whole and no substitute will be offered.
29. If (having made reasonable efforts) the Promoter cannot contact a prize winner, or if a prize winner is deemed ineligible to receive the prize, or if any prize is not accepted or claimed by the Prize Claim Date, the Promoter reserves the right (subject to regulatory approval, if required) to sell the prize. Proceeds from such sale will be paid to the Promoter to be used for not-for-profit game development purposes.
30. If you are a winner, you are responsible for your use of the Prize, including complying with all relevant laws and any applicable terms and conditions of use.

Promoter's use of entries and personal information

31. Upon submission, entries become the joint property of the Promoter, Toyota and Cowboys ('the Parties'). By entering this Raffle, you consent to the Parties using your entry in any media for an unlimited period without compensation for the purpose of promoting this Raffle (including any outcome), and promoting any products manufactured, distributed and/or supplied by the Parties.
32. By participating in this Raffle, each Participant agrees, and each individual who registers as a Club Representative on the Website agrees, that the Promoter, Toyota and Cowboys may use and disclose the personal information provided by you for the purpose of conducting the Raffle and for any of the purposes set out in the Promoter's Privacy Policy (available at www.cowboysfoundatoin.org.au/about/privacy-policy/ or by emailing enquiries@cowboysfoundation.org.au), which contains information about how you may access and seek correction of your personal information or complain about a breach of your privacy, and how the Promoter will deal with that complaint. The Promoter may also disclose your personal information to other parties, including the Promoter's third party service providers. From time to time, these third parties may be located (and so your personal information may be disclosed) overseas, including in the USA and the UK. The Promoter may use your personal information for direct marketing purposes, unless you opt out (which you can do at any time in accordance with the Promoter's Privacy Policy). The Promoter is bound by the Australian Privacy Principles contained in the *Privacy Act 1988* (Cth). If entrants have any concerns or queries about the way their personal information is managed, or wish to access, update or correct any personal information the Parties hold about you, you should contact the Promoter Privacy Officer at Privacy Officer, North Queensland Toyota Cowboys, PO Box 577, Thuringowa Central Qld 4817 or sending an email to enquiries@cowboysfoundation.org.au.

34. The Club Representative and each Participant's consents to having their personal information may be disclosed to State lottery departments if required by law or regulation and to the winner's names being published as required under the relevant State lottery legislation.
35. Any requests to access, update or correct any information should be directed to the Promoter.

The Parties have no control over telephone communications, networks or lines and accept no responsibility for any problems associated with them, whether due to traffic congestion, technical malfunction or otherwise. We are not liable for any consequences of user error including any costs incurred.
37. By participating in the Raffle, you acknowledge that there may be inherent risks in some aspects of the Raffle or the prize and that participation in the Raffle or the prize may involve participating in dangerous activities. By entering this Raffle and/or accepting the prize, you accept that risk for yourself and for your companion(s) (if applicable).
38. To the extent permitted by law, the Parties will not be liable for any loss or damage whatsoever (including direct or consequential loss) or personal injury suffered or sustained in connection with the prizes or this Raffle. The Parties accept no responsibility for any tax liabilities that may arise from winning a prize. Independent financial advice should be sought.
39. The Promoter, Toyota, Cowboys, Cowboys Community Foundation and Good2Give are not responsible for use of a prize which results in:
 - (a) loss that was not reasonably foreseeable;
 - (b) loss that was not caused by the our breach of these Conditions of Entry or by our negligence;
 - (c) business losses (such as lost data, lost profits or business interruptions) or loss suffered by non-consumers;
 - (d) losses caused by factors which could reasonably be considered to be outside our control (such as faults in third party equipment); and
 - (e) any loss caused, or contributed to, by an entrant's breach of these Conditions of Entry or an entrant's negligence.
