



Toyota Good for Footy Gear Grant Program Guidelines

Objective

The Toyota Good for Footy (**GFF**) Gear Grants Program supports female teams across Australia, by providing them with the right uniform and/or apparel. The program is made possible through Toyota Australia Limited's (**Toyota**) partnership with the Australian Football League (**AFL**).

Confirmation of Eligibility

Teams are:

- a female Australian Rules football team
- participating in a competition affiliated with the AFL and/or state affiliate
- <u>a team with all members over the age of 12 years old</u>
- part of a registered club with an ABN number; if not an ABN holder, entrant must complete a 'Statement by Supplier Form' with the ATO located in (and/or supplies services to) Australia

How much are the grants?

The Toyota GFF Gear Grants Program will provide grants up to \$1,600 per team, spread across 100 teams nationally. All grants must be used for the purchase of new or replacement women's football apparel (**Project**).

Where more than the maximum grant to a team's Project cost may be required, specific cases of hardship or special circumstances will be considered. Teams must include details of these special circumstances within the application for consideration

Each team is only eligible to receive one grant; Teams will be selected at Toyota's discretion.

What type of apparel and/or uniform might be funded?

A grant can be used for apparel and/or uniform such as:

- Female football jumpers; and/or
- Female football shorts

What will not be funded?

- Football boots
- Playing equipment (e.g. footballs)
- Training equipment (e.g. cones)





Funding requirements

All teams are responsible for ensuring that the apparel and/or uniform they order using a grant adheres to the requirements of their club, league and/or association. This includes:

- ensuring any club, league and/or association logos are used as required; and/or
- ensuring the order is placed through any preferred or required suppliers, as mandated by their respective club, league and/or association.

How to apply?

All applications for a grant must be submitted via:

 - Applicants must answer all required questions in the application form about their team. Toyota staff
 may be contacted for advice when preparing your team's application at

Teams successful in receiving a grant are required to:

- use the grants for the specified Project;
- ensure they are adhering to apparel and/or uniform requirements mandated by their club, league and/or association;
- must provide an approved tax invoice and artwork proof including the <u>Toyota GFF Gear patch logo</u>. All applications must agree to this in the application process.
- ensure the Toyota GFF Gear patch logo is located on the funded uniform
- complete the Project by no later than 30 April 2021;
- notify Toyota if the Project has been cancelled, and must return all grants paid within 14 days of the Project cancellation;
- share Toyota support messages, display signage and other marketing materials as supplied by Toyota as required or requested by Toyota;
- supply Toyota with a valid tax invoice (receipt) with their team's ABN for the approved grant amount before 30 April 2021, along with a photograph and brief acknowledgement summary of the Project. This can be sent to ToyotaGearGrants@toyota.com.au. If your team does not have an ABN, you must submit a completed "ATO Statement by a Supplier" form to Toyota with your application for a grant. Otherwise 48.5% of your approved grant may be withheld by Toyota. Download the form from the ATO here; and
- complete any evaluation required by AFL or Toyota.





Please note: Successful grant recipients may receive an audit from Toyota

Expected Timeline

- The Toyota GFF Gear Grants Program will be accepting applications between 18 January and 1 February 2021. Applications will only be assessed if all relevant information has been provided.
- Successful entrants will be notified after 8th February 2021 via the email address provided when entering the Promotion. Entrants who are not successful will not be contacted.
- All grant funds must be spent by no later than 30 April 2021.

Payments, Tax Invoices and GST

- Grants are not subject to GST.
- On approval of the grant, the total amount to be paid under the grant will be paid directly to the team's nominated bank account.
- Grants will be paid within 30 days of receipt of a valid tax invoice.
