FULL-SERVICE LEASE

Fees and Charges Guide

Below are Toyota Finance's upfront and ongoing monthly fees.

FEES THAT WILL APPLY

FEE TYPE	DEFINITION	AMOUNT (INCLUDING GST)
Vehicle Security Registration Fee	The cost of registering Toyota Finance's security interest on your vehicle on the Australian Government's Personal Property Securities Register. This is a national online register to help protect consumers when buying personal property like cars, boats or artwork. It allows potential buyers to check if any other parties already have a security interest on the property.	\$6 (upfront fee)
Fleet Administration Fee	A monthly fee for the management of your lease account.	\$18.70/mth
Maintenance Fee	A monthly fee for the management of your maintenance service.	\$7.70/mth
Tyre Management Fee	A monthly fee for the management of your tyre management service.	\$1.10/mth
Registration and CTP Renewal and Fines Management Fee	A monthly fee for the management of your registration and CTP renewal and fines management service.	\$3.30/mth
Fuel Card Fee	A monthly fee for the management of your fuel card management service.	\$3.85/mth

FEE TYPE	DEFINITION	AMOUNT (INCLUDING GST)
Establishment Fee	The cost to set up your approved lease with Toyota Finance. It is payable upon lease settlement and is included within the amount financed.	\$357.50 (upfront fee)

OTHER FEES

FEE TYPE	DEFINITION	AMOUNT (INCLUDING GST)
Early Termination Fee	This fee applies if your Full-Service Lease is terminated before its scheduled end date. You can avoid this fee by continuing with your scheduled lease repayments until the agreed completion date of the lease.	The Early Termination Cost is an amount equal to one third of all Rent payments that would have been payable after the termination date.
Payment Method Fee - Bpay	This fee applies when a payment is made by BPay. You can avoid this fee by setting up a Direct Debit at the start of your loan, so you don't pay fees on your regular repayments.	\$1.50
Payment Method Fee - Other (includes BillPay, Cheque or Direct Deposit)	This fee applies when a payment is made by BillPay, cheque, or direct deposit. You can avoid this fee by setting up a Direct Debit at the start of your loan, so you don't pay fees on your regular repayments.	\$3
Payment Dishonour Fee	This fee applies if your Direct Debit or Cheque payment is dishonoured. You can avoid this fee by checking that your account has sufficient funds when payments are due to be debited.	\$3
Late Payment Fee	This fee applies if you're late or miss a repayment, and your account goes into arrears. Toyota Finance will contact you about the overdue amount.	\$25
Information Fee	This fee applies if you request contract documentation from the Toyota Finance National Customer Solutions Centre.	\$25
